Penelitian ini bertujuan untuk mengetahui Pengelolaan Alokasi Dana Desa dalam mewujudkan *Good Governance* (transparansi, partisipasi dan akuntabilitas) mulai dari tahap perencanaan, pelaksanaan dan pertanggungjawaban Di Desa Carangrejo Kecamatan Kesamben Jombang. penelitian yang merupakan penelitian deskriptif kualitatif dengan teknik pengumpulan data melalui wawancara serta pengamatan langsung secara mendalam kepada narasumber. Hasil dari penelitian ini menunjukkan bahwa Pengelolaan Alokasi Dana Desa di Desa Carangrejo sesuai dengan Peraturan Bupati Jombang No 3 Tahun 2018 dan secara garis besar telah transparan, partisipatif dan akuntabel. Namun dalam hal transparansinya belum banar-benar terbuka dimana penyampaian informasi hanya melalui *banner* untuk media informasi seperti website Desa Carangrejo sudah mempunyai tetapi tidak pernah update karena terkendala tidak ada yang mengelola.

This study aims to determine the Management of Fund Allocation Villages in realizing Good Governance (transparency, participation and accountability) starting from the planning, implementation and accountability stages in Carangrejo Village, Kesamben District, Jombang. research is a qualitative descriptive study with data collection techniques through interviews and direct observation in depth to the speakers. The results of this study indicate that the Management of the Village Fund Allocation in Carangrejo Susuai Village with the Regulation of Jombang Regent No. 3 of 2018 and in general has been transparent, participatory and accountable. However, in terms of transparency, it is not yet fully open where information is only delivered through banners for information media such as the Carangrejo Village website but it has never been updated because it is constrained by no one managing it.
