Dan untuk mengetahui pengaruh profitabilitas kenilai perusahaan melalui kinerja keuangan

Penelitian ini termasuk penelitian deskriptif kuantitatif. Populasi dan sampel penelitian ini ialah data laporan tahunan dan laporan keuangan pada perusahaan sektor makanan dan minuman.go public yang tercatat di Bursa Efek Indonesia. One aspect that is influential in the development of corporate value with intellectual capital that emphasizes more on employees and also human resources is used to understand the knowledge and knowledge used to build good relationships with all groups for the development and progress of a company. This study aims to determine the effect of corporate value profitability through financial performance and to know the effect of intellectual capital on company value through financial performance.

This research includes quantitative descriptive research. The population and sample of this study are annual report data and financial reports on public food and beverage sector companies listed on the Indonesia Stock Exchange. The analysis uses path analysis (path analysis) which is assisted by WarpPLS software. Partial Least Square (PLS).

The results showed that Intellectual capital has an influence on financial performance, Profitability has an influence on the financial performance of the company, Intellectual capital has an influence on company value, Profitability has an influence on the value of the company, Financial performance has an influence on firm value, Intellectual capital has an influence on the value of the company and profitability have an influence on the value of the company through financial performance.
