

PENGELOLAAN DANA DESA DALAM UPAYA MENINGKATKAN PEMBANGUNAN DAN PEMBERDAYAAN MASYARAKAT DESA SEBELUM DAN SAAT PANDEMI COVID 19

Penelitian ini bertujuan untuk mengetahui pencapaian pengelolaan dana desa dalam upaya meningkatkan pembangunan dan pemberdayaan masyarakat desa sebelum dan saat pandemi covid 19 di Desa Nglele Kecamatan Sumobito. Penelitian ini menggunakan metode deskriptif kualitatif. Teknik pengumpulan data yang digunakan adalah dengan pengumpulan data, reduksi data, penyajian data dan penarikan kesimpulan. Hasil penelitian ini menunjukkan bahwa mekanisme pengelolaan dana desa yang dilakukan Desa Nglele sudah sesuai dengan Permendagri Nomor 113 tahun 2014 Tentang pengelolaan Dana Desa, serta dapat meningkatkan pembangunan fisik dan juga pemberdayaan masyarakat Desa Nglele. Pada tahun 2018 capaian pembangunan dan pemeliharaan infrastruktur sosial dasar serta pengadaan sarana prasarana sosial dasar, Desa Nglele membangun saluran irigasi dan tembok penahan tanah/jalan serta normalisasi drainase, sedangkan kegiatan pemberdayaan yang diadakan seperti taman posyandu, pembinaan karang taruna, PKK, GAPOKTAN dan sebagainya. Capaian kegiatan tahun 2020 meliputi bantuan BLT-Dana Desa telah dilaksanakan dengan baik terbukti dari dengan dilakukan pencairan dana desa untuk 133 warga penerima dan kegiatan PKTD-Dana Desa dibuat dalam bentuk pembangunan saluran drainase dan normalisasi saluran irigasi, dimana para pekerja adalah masyarakat yang tidak mempunyai pekerjaan selama pandemi Covid 19.

This study aims to determine the achievement of village fund management in an effort to improve development and empowerment of rural communities before and during Covid-19 pandemic in Nglele Village, Sumobito District. This study used descriptive qualitative method. Data collection Techniques used are data collection, data reduction, data presentation and drawing conclusions. The results of this study indicate that the village fund management mechanism carried out by Nglele Village is in accordance with Permendagri Number 113 of 2014 concerning Village Fund management and can improve physical development and also empower the Nglele Village community. In 2018 the achievements of the development and maintenance of basic social infrastructure facilities, Nglele Village built irrigation canals and retaining walls/roads as well as normalization of drainage, while empowerment activities were held such as posyandu parks, youth youth development, PKK, GAPOKTAN and so on. The achievements of activities in 2020 including BLT-Village Fund assistance have been carried out well as evidenced by the disbursement of village funds for 133 recipients and PKTD-Village Fund activities in the form of construction of drainage channels and normalization of irrigation channels, where the workers are people who do not have work during the Covid-19 pandemic.
