Penelitian ini bertujuan untuk mengetahui prinsip-prinsip *good corporate governance* dalam pengelolaan dana desa di Desa Glagahan Kecamatan Perak Kabupaten Jombang. Jenis penelitian ini menggunakan metode penelitian kualitatif dengan menggunakan desain deskriptif. Pengumpulan data diperoleh dengan melakukan wawancara dan dokumentasi. Teknik analisis data kualitatif yang digunakan adalah model Miles dan Huberman.

Hasil penelitian menunjukkan bahwa masing-masing prinsip *good corporate governance* di Desa Glagahan sudah berjalan dengan baik namun masih ada kekurangan. Ketidakefektifan prinsip-prinsip *good corporate governance* di Desa Glagahan adalah kurangnya memenuhi prinsip transparansi secara sepenuhnya, pemerintah desa seharusnya memiliki situs resmi milik pemerintah Desa Glagahan supaya masyarakat desa dapat mengakses segala sesuatu yang berhubungan dengan pengelolaan dana desa terutama transparansi mengenai laporan realisasi dan pertanggungjawaban APBDesa. Dan kurang meningkatkan pembinaan terkait pengelolaan dana desa kepada masyarakat awam sehingga masyarakat dapat menyampaikan keinginan dan aspirasinya.

This study aims to determine the principles of good corporate governance in managing village funds in Glagahan Village, Perak District, Jombang Regency. This type of research uses qualitative research methods using a descriptive design. Data collection was obtained by conducting interviews and documentation. The qualitative data analysis technique used is the Miles and Huberman model.

The results of the study indicate that each of the principles of good corporate governance in Glagahan Village has been running well but there are still shortcomings. The non-optimal principles of good corporate governance in Glagahan Village are the lack of full compliance with the transparency principle, the village government should have an official website belonging to the Glagahan village government so that village communities can access everything related to the management of village funds, especially transparency regarding the APBDesa realization and accountability report. And lack of improving guidance related to the management of village funds to the general public so that the community can convey their wishes and aspirations.
